1. OPEN AND WELCOME

The Chair opened the meeting and welcomed everyone present.

The Chair advised that 2 apologies, 3 Letters of Representation and 2 Proxies had been received. The Chair further advised that three Shareholders present in person or by Proxy representing at least 1% of the total votes in the Company constituted a quorum as the Shareholders present represented 42% of the total votes, the Chair accordingly declared the meeting as duly constituted.

**3. MINUTES OF THE PREVIOUS ANNUAL SHAREHOLDERS MEETING HELD ON THE
19TH OF SEPTEMBER 2016**

The approved Minutes had been circulated and there were no matters arising from the Minutes.

4. PRESENTATION OF THE CHAIR'S REPORT

The Chair's Report having been circulated was accepted as read, the Chair highlighted pertinent aspects of the Report and after discussion the meeting accepted the Chair's Report and approved the actions of the Directors.

6. APPROVAL OF AUDITOR'S REMUNERATION

The Meeting considered the fees raised by the Auditors for work completed and as there were no questions or objections, the Shareholders:

7. APPOINTMENT OF AUDITORS

As there was no counter proposal or objection to the reappointment of the Auditors, Theunissen Abrie Incorporated, the Auditors therefore remained in office for the ensuing financial year.

8. INSURANCE SCHEDULE

The meeting considered the circulated Insurance Schedule detailing the insured values, premiums, Broker and Insurer / Re-insurer and discussed the decrease of the sum insured for Building Combined cover and the Business Interruption and as there were no questions or objections, it was:

RESOLVED BY UNANIMOUS RESOLUTION THAT:

The sum insured for Buildings Combined cover be decreased from R13 688 179.3 to R12 240 199.71, the indemnity period of Business Interruption be lengthened from 12 to 24 months and that the amended Insurance Schedule be and is hereby approved.

9. ELECTION OF DIRECTORS

9.1 Mr. J van Niekerk confirmed that in terms of the provision of the Mol the minimum number of Directors were three and in terms of Clause 19.1 half of the number of the Directors shall retire. Mr. JH Pretorius retired and had indicated that he was available for re-election.

9.2 One Nomination was received for Mr. JH Pretorius to fill the vacancy.

RESOLVED BY UNANIMOUS RESOLUTION THAT:

Mr. JH Pretorius be and is hereby appointed and elected as Director for the ensuing year.

9.3 Mr. J van Niekerk congratulated Mr. JH Pretorius on his appointment.

10. VOTE OF THANKS AND DISSOLUTION OF MEETING

The Chair thanked VRS and the accounting staff for their assistance and contributions in ensuring good Corporate Governance and controls and thanked the Resort Management for their exemplary management of the Resort resulting in the continuous flow of compliments. The Chair thanked the Shareholders for their loyal support and prompt levy payments.

As there were no further matters for discussion the Chair dissolved the meeting.
